

SUMMARY ANNUAL REPORT FOR CORPORATE RISK HOLDINGS, LLC HEALTH & WELFARE PLAN

This is a summary of the annual report of the Corporate Risk Holdings, LLC Health & Welfare Plan (Employer Identification Number 52-1969985, Plan Number 501) for the plan year January 1, 2018 through December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Corporate Risk Holdings, LLC has committed itself to pay certain medical and dental claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Vision Service Plan (VSP), Pre-Paid Legal Services, Inc. dba LegalShield, ComPsych The Guidance Resource Company, Liberty Life Assurance Company of Boston, Prudential Insurance Company of America and Aetna Life Insurance Co. to pay certain vision, legal, employee assistance program, life, accidental death and dismemberment, business travel accident, long-term disability and hospital indemnity claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2018 were \$880,517.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2018, the premiums paid under such "experience-rated" contracts were \$206,302 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$158,538.
